3. GENERAL BUSINESS

3.1 Regional Wheelchair Accessible Vehicle Grant Department of Transport

- Grants of up \$65,000 to support the establishment of new taxi services where none exist.
- Grants of up to \$45,000 to support existing WAV taxi service providers to replace an ageing WAV taxi, or purchase an additional WAV taxi vehicle to meet demand.

Information was also shared about some changes being made to the Department of Transports Taxi User Subsidy Scheme. The Taxi User Subsidy Scheme (TUSS) is a subsidy available to eligible people with disability travelling in on-demand rank or hail (taxi) vehicles. TUSS participants can receive up to 75% off eligible taxi fares. 3.2 Update on Shire Projects

Footpaths:

- Attached is the current map for the next stage of the footpaths
- Existing footpaths have the tactile dots in the wrong location this has been picked up in an audit.
- It is recommended that DAIC members (and all community members) log issues like the above, or any other Shire related incident in the app Snap Send Solve. This sends the issue directly to the person responsible for fixing it.

KLC Redevelopment

• This project has been put on pause as the Shire is waiting for more funding from DLGSC. The request is currently sitting with treasury and the delay is expected to last until next year.

All Abilities Playground

- This is currently out for EOI which closes in November. Businesses will then be invited to provide a tender submission.
- The Shire has received lots of queries regarding the EOI so it is expected there will be some good submissions
- This project is anticipated to start mid next year

Department of Communities has not yet given any formal feedback except that they were excited about the all abilities playground.

3.4 Wayfinder Update

International Day of People With Disability

- Wayfinder and the Shire were successful in receiving grants to run the event in Kununurra
