Boating and Use Guide

IMPORTANT - Refer to the Department of Transport Boating Guide – Kununurra – Wyndham Marine Safety

Crocodile Safety

DANGER - Crocodiles inhabit this area. Attacks cause injury or death.

- Keep away from the water's edge.
- Do not enter the water.
- Take extreme care when launching and retrieving boats.
- Do not clean fish near the water's edge.
- Remove all fish and food waste.

VHF Routine Calling / Replying Procedures and Emergency Marine Radio Operation

CH 80 Wyndham Port Area – Logging on and logging off

Vessel to establish communication with receiver, base or other vessel by stating who they are by call sign (EK number or vessel registration) 3 times, for example:
**Sea Rescue Base, Sea Rescue Base, Sea Rescue Base – this is EK..., EK..., EK...
 are you receiving over?**
 Once good communication is established, call the receiver once and establish who you are twice, for example:
Sea Rescue Base this is EK..., EK...
 Reply with agreement to go to working channel.
 "Over" means inviting response.
 "Out" means end of exchange.

VHF Wyndham

Distress / Calling Channels 16, 80, 81:

- **Ch 16** – Emergency/Distress Channel (direct line of sight calls only - no repeater)
- **Ch 80** – South of Nicol Pt – Wyndham Port area (preferred emergency)
- **Ch 81** – North of Nicol Pt – Approx 50 km north of Wyndham (preferred emergency)

Ch 11, 12, 14, 17 – Suggested for boat to boat chat channels.
Note: Channel 80 - 81 are solar powered repeater stations **not** chat channels.
 Please leave radio turned on after logging on.

Shire of Wyndham East Kimberley Local Government Property - Local Law 2003 Local Government Act 1995

Polluting surrounding area

A person shall not tip or deposit anything onto the boat launching ramps, floating gangway and pontoon or the jetty and pontoon so as to pollute the surrounding area.

Fishing

A person shall not fish from the boat launching ramps, floating gangway and pontoon or jetty and pontoon so as to obstruct or interfere with the free movement of a boat approaching or leaving the water or mooring, nor unreasonably cause any obstruction or impede the free passage of other persons on the boat launching ramps, floating gangway and pontoon or jetty and pontoon.

Permitted Use:

- **Boat launching ramps, floating gangway and pontoon**
 The boat launching ramps, floating gangway and pontoon are for the use in assisting launching and retrieval of boats only. A maximum of five (5) persons shall be on the floating gangway and pontoon at any one time. No mooring is permitted for a consecutive period exceeding 2 hours without the prior consent of the local government.
- **Jetty and pontoon**
 - The loading of goods greater than 100kg and transfer of fuel between the jetty and vessels are not permitted.
 - The mooring of boats or small vessels less than or equal to 500t at the jetty and pontoon is permissible when:
 - the boat is in distress and then only to effect the minimum repairs necessary to enable the boat to be moved elsewhere and then not for a consecutive period exceeding 2 hours without the prior consent of the local government (contact details for the Shire of Wyndham East Kimberley below); and
 - the embarking or disembarking of passengers or the loading or discharging of cargo or other goods is in progress, and then not for a consecutive period exceeding 2 hours without the prior consent of the local government (contact details for the Shire of Wyndham East Kimberley below).
