#### **WASTE CHARGES**

Waste collection, disposal, and tip maintenance, including a contribution to waste management within the Shire, is funded by these charges:

- Waste Management Charge of \$200 per annum.
- Waste Receptacle Charge of \$315 per annum for a once weekly waste collection or \$515 per annum for exempt/non-rateable properties.
- Additional waste collections are charged at \$515 per receptacle per service per annum, which is inclusive of the waste management charge and waste receptacle charge.

#### KUNUNURRA AND WYNDHAM LANDFILL

Kununurra and Wyndham Landfill sites will accept free domestic waste as of 1 July 2019. Domestic Waste is defined as anything that would go inside your curbside bin.

The Shire will continue to provide it's two free waste weekends in March and November to allow for the disposal of any larger domestic items such as couches, washing machines, etc

# **EMERGENCY SERVICES LEVY (ESL)**

This is a levy imposed by the Department of Fire and Emergency Services (DFES) and collected on its behalf by Local Government in Western Australia.

# The 2019/20 declared minimum ESL charge is \$84.00.

# PENSIONER/SENIORS

If you hold a current Pension Concession Card (not a Health Care Card) or a Veteran Affairs Gold Card, which stipulates TPI or War Widow, you may be able to claim a rebate on your sole or principal place of residence.

New applications can be made by phoning the Water Corporation on 1300 659 951. If you remain eligible and received the rebate last year you do not need to reapply, the rebate amount will be shown on your Rates Notice.



# **CHANGE OF POSTAL ADDRESS OR PROPERTY OWNERSHIP**

If you've changed your address or you're about to, please let us know straight away.

It is the legal responsibility of the property owner to advise the Shire, in writing, if you:

- Change your mailing address and/or residential address.
- Change your name (copy of driver's license or relevant certificate required).
- Wish to nominate an agent to receive your rates notice.
- Wish to nominate your tenant as the ratepayer (ie. as the recipient of the rates notice).

A change of Name & Address form is available from the Shire's website www.swek.wa.gov.au/documents/86/change-of-address. This form must be completed and signed by the property owner/s.

Delays in mail or payments due to an incorrect address are not considered to be an acceptable.

Local Government rates are levied annually on all rateable properties. They provide Council with the revenue needed to manage the services and facilities which make the Shire a vibrant and attractive region to live in.

- Anthon's Landing and Kununurra and Wyndham boat ramps
- Reticulation upgrades
- Street lighting
- Weed and Bush Fire Control
- Tourism and Business Development services.
- Economic Development including the Wyndham Port study and funding the trial of direct flights to Melbourne
- Community events and promotion though our community grants funding, supporting such things as the Ord Valley Muster, Lake Argyle Swim, Kununurra Agricultural Show, Dam to Dam, East Kimberley Aboriginal Achievement Awards.

Ratepayers can elect any instalment option offered above by paying the applicable first instalment amount as per the rates notice ON OR BEFORE the first due date.

Interest is charged on all overdue balances. The penalty interest rate is currently 9% for Rates and 11% for ESL per annum calculated daily (excluding eligible pensioners and seniors).

If the instalment options shown above are not suitable, ratepayers may request a weekly, fortnightly or monthly payment arrangement at a charge of \$61.30. Contact the Rates Officer for further information.

Rate payments MUST be received by the Shire of Wyndham East Kimberley by the due date. Please consider this when choosing your method of payment and the length of time for the payment to be received by the Shire.

#### **DIFFERENTIAL & MINIMUM RATING**

The Shire applies differential rating categories which are determined by land use, zoning, or a combination of these to best reflect the rate in the dollar (RID) contribution from the different property groups for the use of community assets.

A minimum payment is established and maintained to ensure all ratepayers make a reasonable contribution. Where the rates calculation provides a figure lower than the minimum, then the minimum payment will apply.

This system ensures owners of all types of properties make a proportionate contribution.
