2. Pre-incorporation meeting: To set up a new Aboriginal Corporation under the Corporations (Aboriginal and Torres Strait Islander) Act 2006 (Cth) (CATSI Act) that will become the prescribed body corporate (PBC) for the area of the Purnululu and Gajangana Jaru Claims. This will include persons who will become members of the PBC on registration making decisions to:

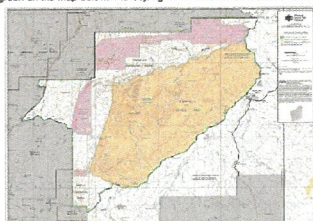
- approve the PBC Rule Book (and confirm replaceable rules that will apply to the PBC);
- nominate the directors on registration for the PBC; and
- nominate a contact person; and

d. authorise a person to submit the application for registration of the PBC to ORIC.

3. Nomination of the PBC:

Do the Purnululu and Gajangana Jaru Native Title Claimants instruct a representative to nominate a corporation to be the prescribed body corporate for the area of the Purnululu and Gajangana Jaru Claims and to hold native title on trust once it is incorporated?

The Purnululu Claims are shown outlined in green on the map below. The Gajangana Jaru Claim is shown shaded in yellow.



The KLC provides legal representation for the Purnululu Claims. Roe Legal Services provides legal representation for the Gajangana Jaru Claim. Lawyers from the KLC will be at the meetings to provide advice on the determination of native title and development of a Prescribed Body Corporate.

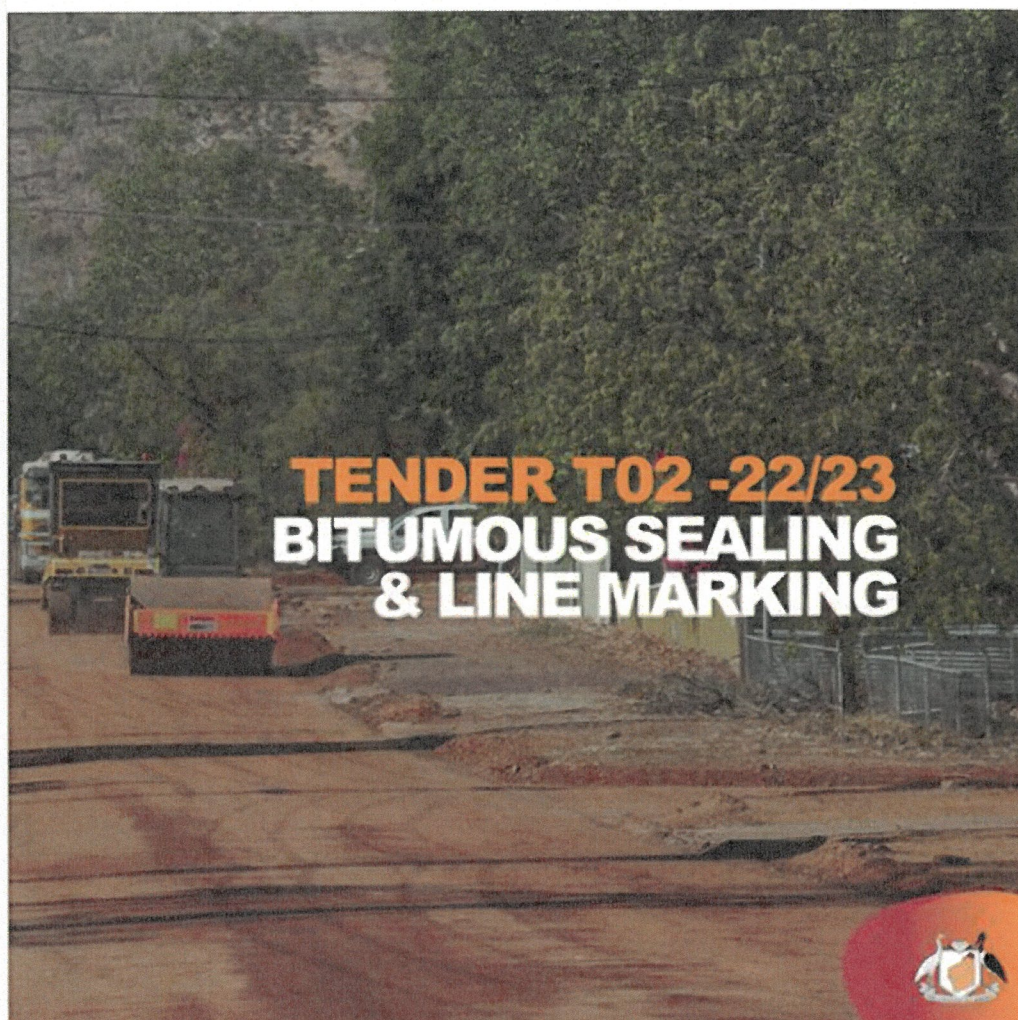
