

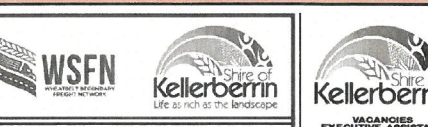

Invitation for Public Comment

This notice amending the notice published by Main Roads on the 7th September 2022 is published pursuant to Section 95A(3) of the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act).

Main Roads Western Australia proposes to construct and maintain Stage 4 of the Karratha to Tom Price Road, Western Australia, between the end of the Stage 3 Road at Waiyunga Pool (on the existing Roubouma – Wittenoom Road) and the Nanutara – Murgina Road, approximately 26km north of Tom Price, Western Australia.

This section of sealed road will directly link coastal and inland communities of the central Pilbara.

The proposed action has been determined to be a controlled action under the Environment Protection and Biodiversity Act 1999 (EPBC Act) and will be assessed through Preliminary Documentation. The controlling provision under Part 3 of the EPBC Act is listed threatened species and communities (section 18 and 18A).

In accordance with Section 95A(3) of the EPBC Act, Preliminary Documentation related to the proposed action is available for viewing and comment for a minimum of 10 business days from date of advertisement.

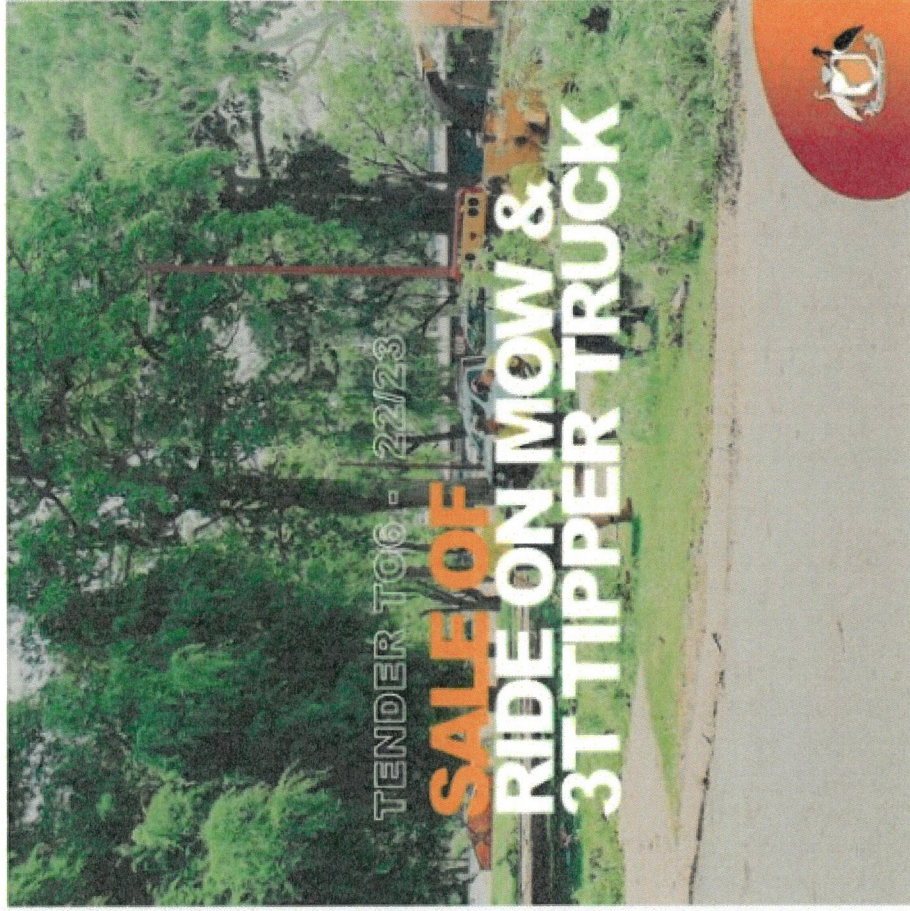
