#### **Question from Mark Coventry, Kununurra:**

I would like the drainage on Jabiru Road to be looked into?

#### **Response from CEO V Lawrence:**

The matter was taken on notice to be investigated by the Director Infrastructure for a response.

#### **Question from Mark Coventry, Kununurra:**

As a local Business Owner in a profession that could assist in repairing the old weed harvester (previously owned by the Shire/that is still located in Kununurra) I have a two-part guestion:

Firstly, as a possible business opportunity, if I invest my skills and time in repairing the old weed harvester and assist in cleaning up and maintaining the excessive amount of Cumbungi weeds in Lily Lagoon, would this be something the Shire would support? and secondly, if not, what is Council's plan regarding the Cumbungi weed issue?

#### **Response from CEO V Lawrence:**

This is a topic that has been in recent conversations between both the Council and the Administration as we have been approached by a number of members of the community with this same concern. So, we are very aware of the matter and it is something we want to address.

The legal environment around it as we understand it, is that Water Corporation owns the water and we do not have sole rights regarding the land side aspect of the Lagoon. This means the management of the lagoon is not a Shire responsibility as it is not a Shire asset, and we have no control over that aspect of it. Where we do have a role and the

opportunity to provide input is around advocacy on this issue due to the community interest in that space and because no one else is taking responsibility for it.

There has been a number of recent conversations regarding what stepping in to this space looks like in regards to what plant and equipment is required, what resourcing is needed, how waste product collected is collected, transported and treated etc. It is quite a big project. As an administration, I would rather allocate a budget item as a contribution to someone on an annual basis to get the work done than over stretching our current staff compliment and resourcing. If you have an idea on how that can work, we welcome having a detailed discussion with you on how we can achieve this objective at East Lily Lagoon and for inclusion in our considerations as part of our upcoming budget process.

Councillors present noted the link between the Lake Kununurra Foreshore Plan and this objective which will be considered as part of the current review of this plan.
