5.5 Statement from Anne Wright, Bull Run Road, Kununurra

Taking money out of the Airport Reserve to fund the direct flights to Melbourne is of concern. The reserve fund is not for this purpose, it is to improve facilities at the airport.

AirNorth and Virgin have been serving Kununurra for a long period of time and they do not get any special consideration so the Shire should not be taking money from the Airport Reserve to fund additional flights.

Response from CEO, Carl Askew

A report went to Council recently in regards to the direct flights to Melbourne and the outcome of this was that Council advertised for a change in the purpose of the Airport Reserve in order to utilise the funds for strategic purposes that are not operational/maintenance focused. Council has not made a decision yet in relation to the flights to Melbourne or the use of the reserve. Due to the commercially sensitive nature of this matter briefings to Council to date have been confidential.

A report on the change of purpose of the reserve will be considered by Council next week and Mrs Wright's comments will be included.

The Shire President offered additional information regarding recent meetings with various politicians while in Canberra on business recently. The suggestion was made to develop a better business plan in order to assist seeking funding for a runway extension/improvement.
