On 23 June 2022 authorised officers, Anna Peace and Lorraine Beugelaar visited Ewin Early Learning Centre Inc (1 Chestnut Avenue, KUNUNURRA WA 6743). Amanda Ireland was present at the service during the visit.

The purpose of the visit was to conduct a proactive spot check.
