The appropriateness of Drag entertainment for children when a person, usually male, imitates and exaggerates female gender signifiers and gender roles for entertainment purposes, is highly contested and should not be an activity held in a rate funded facility for many reasons:

1. The practice is highly offensive to females
2. The sexual nature of drag entertainment is inappropriate for children
3. Telling or implying to our kids that 'trans' is great is highly controversial. Medical experts warn of the danger of confusing children about their biological gender when the effects of puberty blockers, cross sex hormones and surgery are known to be harmful.
