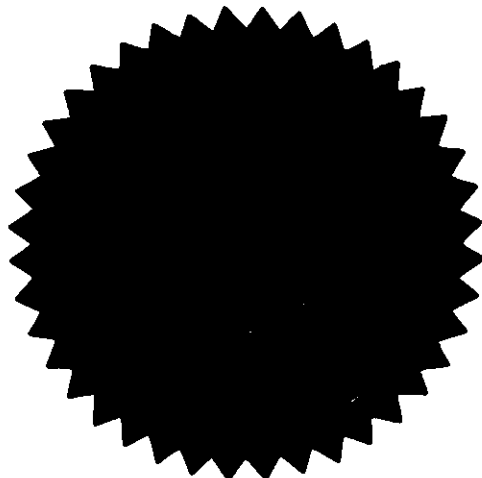

RE: Kalumburu Basketball Centre upgrade

This is a letter of support for the funding application to complete upgrades to the Kalumburu Basketball Centre.

The basketball courts in Kalumburu community are well overdue for an upgrade.

The basketball courts are a huge part of the social fabric for the community. The courts are utilised by many members of the community on a daily basis throughout the year. It is the hub of the community where people meet to play and watch sport, dance, play music and hold community events.

The Kalumburu Aboriginal Corporation staff and community members organise many events and activities at the basketball area. The positive impact the events have on the wider community is visible from afar.

The use of the basketball courts by community members reduces the criminal behaviour of the community youth, that at times have been involved in unlawful activity. A recent survey conducted by Kalumburu Police identified the primary cause of criminal behaviour demonstrated by community youth is due to 'boredom'.

The installation of CCTV is always supported and encouraged by WA Police. The presence of CCTV reduces criminal activity and unruly behaviour of people. The knowledge of knowing what they are doing is being recorded generally changes their behaviour and actions in a positive way.

The improvement of lighting is always a positive move. It enables activities to be supervised in a safe environment. Many of the activities held at the basketball courts in Kalumburu are held during the evening due to the extreme weather experienced during daylight hours. Lighting enhances personal safety.

Establishing a storage area for sporting equipment and an office area will ensure equipment won't get lost, misplaced or stolen. It will provide an area for people who coordinate sporting activities and events a space to complete necessary office duties opposed to returning to the Kalumburu Aboriginal Corporation office.

Kalumburu Police supports the application for funds to improve the basketball court area at Kalumburu.

I understand the Kalumburu Aboriginal Corporation are currently seeking funding to provide an upgrade to the basketball court at Kalumburu and I would like you to accept this letter on behalf of Department of Communities, in support of the proposal.

Due to the remote nature of the community, there are limited facilities and services for the young people to access in relation to recreational and leisure activities. The basketball court is well utilised by KAC and the community for a range of activities including; basketball competitions, discos and as a general day to day play area for the children and young people. The facility, however, requires painting and resurfacing and would also benefit from an ablution block and kitchenette, to extend the activities able to be held in the area.

The availability of safe spaces and activities, that engage the young people and children in the community, reduces their involvement in anti-social behaviour and their risk of harm, and provides engagement in positive recreational activities their peers.

This letter is to express Kalumburu Remote Community School (KRCS)'s support for funding to be awarded to the Kalumburu Aboriginal Corporation (KAC) to upgrade the existing 'Indoor Court' basketball and recreation facility.

The current facility is significantly aged and not fit-for-purpose by current standards. Areas of need include:

- Toilet facilities. There has never been a toilet at the facility and this results in people using the area behind the court as a toilet, creating a smelly and unhygienic area.
- Drinking fountain and taps. There has never been a drinking fountain at the facility, and the original tap has been out of service for a long time. Children/youth/adults are playing sports in a hot and humid climate with no access to drinking water. The closest taps to the facility are in the yards of teachers and nurses, leading to unwanted trespass on properties, gates being left open and vandalism.
- Multipurpose room for first aid, office space, kitchen etc. There is no indoor space at the facility. When events requiring catering all bbq/gas/esky/food preparation utensils must be brought from elsewhere and taken away dirty to clean elsewhere.
- Upgrade to the existing playing surface, lighting and sound systems. The surface is standard concrete and not a safe, non-slip basketball surface. Lighting is dated and a speaker is carried over for events as there is not installed speaker system.
- The roof is accessible by children/youth. A design which prevents their climbing would improve safety for this risk-taking age group.
- Weather-proofing/360 roller doors and fans would make the facility usable throughout the tropical wet season.

Children and youth have little access to recreational activities in Kalumburu and their love of basketball is strong. As well as a healthy past-time, community members often use basketball as a stress-relieving, de-escalation tool when they are facing problems or to diffuse anger they are feeling. A modern, multi-purpose, all-weather facility would greatly benefit the wellbeing of children, youth and adults in the community. It would be a safe and well-used place for recreation, fitness and escape from stressors at home when they arise.

KRCS fully supports KAC's application for funding to make these improvements, and knows the facility would serve, and be valued by, the community long into the future.
