PROJECT DETAILS Project Title (brief and specific): Kununurra Multi-Sport Storage Shed **Project Description:** This project involves 8 Kununurra sporting clubs banding together to address a common needlack of facilities to store and keep sporting equipment safe. One large shed would be built (big rectangle, see attachment A) and each club would have their own lockable section with power and a shared water point outside. How did you establish a need for your project? The reason for needing a storage shed are: • sporting equipment is currently been stored at various club member houses (filling up there sheds) equipment is not been looked after (left in rain) equipment been stolen (need somewhere for safe keeping) there are boxes and boxes of meeting minutes dating back to the 1980's in club member houses (weather proof cabinet in new shed will be great for all of these) and annovance of having club members going through shed to pick up equipment because you are out of town (need a central location for community sporting equipment). What alternatives were considered and why were they rejected (e.g cost, suitability, feasibility)? No other alternatives have been tabled, basically if a shed is not built then the status quo remains and expensive sporting equipment is damaged/lost, club member frustrations continue and sport and the community are no better for it. Have the full lifecycle costs of the project been considered and can you afford the ongoing costs of managing, maintaining and replacing the facility? Will a specific asset replacement fund be created? We are proposing to build a shed (concrete floor and steel frame), there is not expected to be any unmanageable full life cycle costs. If we could minimise these game day hassles we may encourage more committee members and lighten the load on current members, giving them more time to organise extra sporting events – there is plenty more sporting events that could be held, we just need the legs on the ground to do it.








Side on view of shed looking at side, where Touch Jooky and AFL are.



Memorandum of Understanding

Between

Users of Multi Sport Storage Shed (located at the Ord River Sports Club Inc)

and

Ord River Sports Club Inc

This Memorandum of Understanding (MOU) sets the terms and understanding between users of the Multi Sport Storage Shed and Ord River Sports Club Inc to formalize management of this facility into the future including: fees, unit tenancy, maintenance and insurance.

Background

Funding was secured in early 2018 by a combined effort of Kununurra sporting groups to build a 'multi-sport storage shed' on land owned by the Shire of Wyndham East Kimberley and leased by the Ord River Sports Club Inc.

The Ord River Sports Club gratefully made land available close to Kununurra Town Oval where users of the shed play their sport. It was desirable to work with the Ord River Sports Club to minimise utility and insurance costs and support the community owned/managed club. It was also desirable for the Ord River Sports Club Inc to welcome the various sporting groups—supporting and encouraging sport in Kununurra.

Users of the Multi Sport storage shed are:

- Mens Cricket
- Womens Cricket
- Junior Cricket
- Rugby League
- Junior Rugby League
- Aus Kick
- Junior AFL
- T-ball and
- Touch Football

Purpose

This MOU formally outlines what is expected of 'users of the Multi Sport Storage Shed' and the 'Ord River Sports Club Inc' to ensure successful management of this asset into the future.

The above goals will be accomplished by undertaking the following activities: Fees:

- Fees paid to Ord River Sports Club Inc by Cricket and Rugby League will be \$250/year
- Fees paid by other users will be \$100/year
- Fees will be capped for five years and then reviewed
- Fees are to be paid at the start of each financial year in advance

Unit Tenancy:

- The shed is owned by each respective sporting group that was part of the funding application to SWEK and DSR
- The Ord River Sports Club Inc own the land on which the shed is built

Shed Maintenance:

• Each respective sporting club is responsible for maintaining their unit. For example, changing lights, fixing doors and replacing faulty power points

Insurance:

- The shed structure will be covered under Ord River Sports Club Inc insurance
- Contents of the shed will not be insured under Ord River Sports Club Inc insurance and each respective club will need to organise their own insurance through their respective state sporting authority

Reporting

After six months from the signing of this letter a representative from each respective sporting club using the facility and President of the Ord River Sports Club Inc will meet and evaluate the management of this facility.

Duration

This MOU is at-will and may be modified by mutual consent of authorized officials from Mens Cricket, Womens Cricket, Junior Cricket, Rugby League, Junior Rugby League, Aus Kick, Junior AFL, T-ball and Touch Football and the Ord River Sports Club (partners). This MOU shall become effective upon signature by the authorized officials from the above listed partners and will remain in effect until modified or terminated by any one of the partners by mutual consent.
